



5. To the best of my recollection, I have never been previously been admitted *pro hac vice* in this Court.

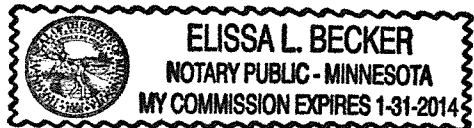
